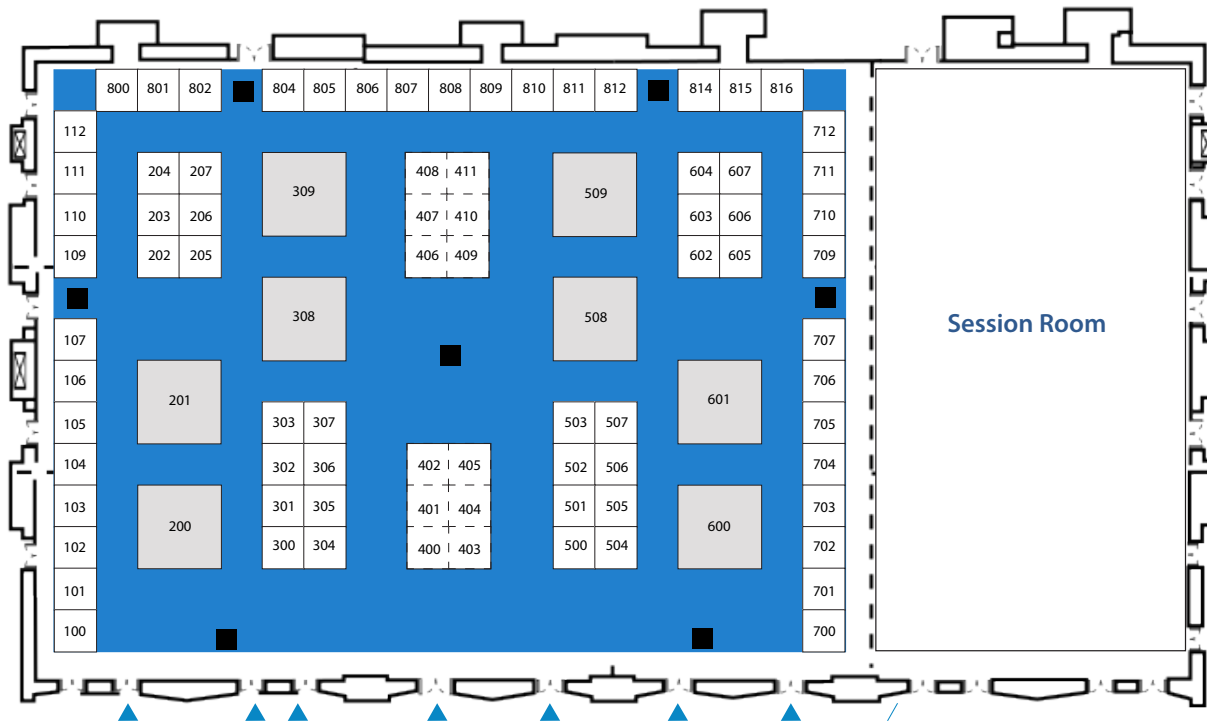




Exhibition Opportunities
